



Step 2 This Dance Studio Policies

Tuition

Tuition is non-refundable. \$35 return check fee. If tuition is not paid 2 weeks into the session there will be a \$25/month late fee.

Tardiness

It's important to be on time for classes. Late-comers miss the important warm-up exercises and miss valuable instruction. Students who arrive 15 or more minutes late may not be allowed to participate in the class unless special arrangements have been made.

Dancewear & Appearance

All classes have dress code requirements. Students who are not suitably dressed will not be permitted to participate in the class. Shoes should be labeled with your dancer's name. Dance shoes are to be reserved for the dance floor and never worn outdoors. Hair must be neat and off the face.

Ballet: Leotard, pink tights, pink ballet shoes. Hair in a bun.

Jazz: Leotard and tights or leggings. Tan jazz shoes.

Lyrical/Contemporary: Leotard and tights or leggings. Bare feet or half soles.

Acro: leotard and tights. Can wear booty shorts. Bare feet.

Tap: Leotard and tights or leggings. Jazz taps preferred.

Hip Hop: Comfortable clothing, NO BARE KNEES! Sneakers, ABSOLUTELY NO STREET SHOES!

Waiting Areas

Parents are welcome to wait in the waiting area. Please remain silent during class and have your electronics on silent or vibrate to not interfere with or distract from class instruction. Dancers waiting between classes must do so quietly.

Miscellaneous

Important information is delivered to via email.

Step 2 This Dance Studio is not responsible for lost or misplaced articles.

We are not responsible for injuries sustained while in the classroom or on the school premises.

Foods and beverages other than water are not permitted on or near the dance floor.

We ask that street shoes be removed before stepping on the dance floors.

Dance shoes should be reserved for the dance floors, and never worn on outside.
